The amendments to the Storage Service Rules of 1 April 2022 (version 004) incorporating Amendment No. 1 dated 20 May 2022 and Amendment No. 2 dated 9 August 2022 (the "Rules") included in this Revision Sheet result from the need to clarify the provisions of Schedule 9 A and Schedule 9B to the Rules, which contain information clauses concerning the processing of personal data of representatives, employees and associates of the clients of Gas Storage Poland sp. z o. o. ("GSP"), and of the clients of GSP.

The amendments are subject to consultations with the market in accordance with clause 1.7.2 of the Rules.

- 6. Your personal data will be processed for the following purposes:
 - a. for the purposes of performance of an agreement between GSP and the client on whose behalf you are actingentity you represent, or to undertake actions aimed at its conclusion, the legal basis for the processing being a legitimate interest of GSP and of that entity (Article 6(1)(f) of the General Data Protection Regulation 2016/679 – hereinafter: GDPRGDPR); the legitimate interest is to ensure, which consists in ensuring the reliable identification of the contractor client and its representative.

 - for the purposes of fulfilling the legal obligations of GSP under other generally applicable laws, including specifically those related to accounting and tax law, the legal basis for the processing being Article 6(1)(c) of the GDPR;
 - c. for the purposes of asserting, pursuing or defending against claims, if any, the legal basis for the processing of your data being Article 6(1)(f) of the GDPR i.e. the legitimate interest of GSP (Article 6(1)(f) of the GDPR); the legitimate interest is to allow which consists in making it possible for GSP to pursue or defend against claims related to the procurement procedure and the performance of the agreement concluded with yourself.
